

**WAIVER OF LIABILITY; INDEMNIFICATION AGREEMENT  
AND COVENANT NOT TO SUE**

**NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. BY ELECTRONICALLY SIGNING THIS AGREEMENT, YOU AGREE TO GIVE UP YOUR RIGHT TO BRING A COURT ACTION TO RECOVER COMPENSATION OR OBTAIN ANY OTHER REMEDY FOR INJURIES TO YOURSELF OR YOUR PROPERTY ARISING OUT OF YOUR USE OF CAMP SUMTER GUN CLUB NOW OR ANY TIME IN THE FUTURE.**

I hereby acknowledge and agree that target and competition shooting, firearms training, the use of firearms and the use of the CSSSA, Inc. d/b/a as Camp Sumter Gun Club facilities located in Macon County, Georgia ("CSGC") may be dangerous and may involve the risk of serious bodily injury or death. I have full knowledge of the nature and extent of all of the risks associated with the use of the CSGC facilities, including, but not limited to: (1) all manner of injury, including, but not limited to death, injury, and/or paralysis arising from the use of firearms or their discharge; (2) injuries resulting from intentional or inadvertent discharge of firearms by myself or others using the CSGC facilities, including loss of hearing, burns, blindness, other injury or death; (3) injuries or death resulting from explosions, contact with projectiles and hardware; (4) failure or misuse of any equipment, whether owned and maintained by CSGC or otherwise, and (5) any other injuries that might occur in an outdoor setting including but not limited to trips, falls, sun exposure, stings and bites from venomous insects and reptiles. I have been encouraged to use vision and hearing protection at all times when present on the facilities of CSGC. If I choose not to use such protection, I agree to assume the additional risks associated with lack of their use. I acknowledge that the above list is not inclusive of all the possible risks associated with my use of CSGC and that the above list in no way limits the extent of this Waiver of Liability/Indemnification Agreement and Covenant Not to Sue.

In consideration of my use of CSGC, I agree to release and, on behalf of myself, my heirs, representatives, executors, administrators and assigns (the "Releasors"), **HEREBY DO RELEASE** CSGC, its owners, shareholders, officers, directors, employees, volunteers and agents (the "CSGC Releasees") from any cause of action, claim, or demand of any nature whatsoever which the Releasors may now have or have in the future against the CSGC Releasees on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to my use of CSGC, whether that use is supervised or unsupervised, and however the injury or damage is caused, including but not limited to the negligence of the CSGC Releasees. I further covenant that, in consideration of being allowed to use the CSGC facilities and equipment, I shall bring no civil action against the CSGC Releasees based upon any of the foregoing. I understand that I will be solely responsible for any loss or damage including, but not limited to, death or paralysis, that I may sustain while using CSGC and that by signing this Agreement, I am relieving the CSGC Releasees of any and all liability for such loss, damage or death.

I do hereby further agree to **INDEMNIFY AND HOLD HARMLESS** the CSGC Releasees from any and all causes of action, claims, demands, losses or costs of any nature whatsoever arising out of, or in any way relating to, my use of CSGC. I further certify that I am in good health and that I have no physical limitations that would preclude my safe use of CSGC facilities and any equipment thereon.

I acknowledge that the foregoing agreement is intended to be as broad and inclusive as permitted by the laws of the State of Georgia and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. I understand that the terms of this agreement are legally binding and that I am signing this agreement, after having carefully read it and of my own free will.

I certify I am a citizen or legal resident of good repute of the United States of America; that I am not a member of any organization or group having as its purpose or one of its purposes, to overthrow by force and violence, or by subversion, of the Government of the United States or any of its Political Subdivisions; that I have never been convicted of a felony; and, if admitted for membership, I will fulfill the obligations of good sportsmanship and good citizenship, and will abide by all the By-Laws and Rules established by the Camp Sumter Gun Club. I certify that I can lawfully own and use a firearm. By electronically signing this form, I agree to be bound by the Waiver of Liability and Covenant Not to Sue.

I certify that I have read the Range Safety Rules and Liability Waiver. By checking this box, I agree to be bound by the Range Safety Rules and the Waiver of Liability.
